- The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The
 relevant books as per the academic level of students shall be made available in the library.
- 7. The School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of internet always on from any service provider to be ensured.
- The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the
 equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules.
- 9. The school will also abide by the conditions of Recognition/NOC prescribed by the State Government concerned.

- a) The school in India must pay salaries and admissible allowances to the staff not less than the corresponding categories of employees in the State Government schools or as per scales etc. prescribed by the Government of India-Further, the service conditions as per Rule 10 and Rules 24 to 49 of Affiliation Bye-Laws shall also be
